Take Exit 10 from 1-205 and head south on State Highway 213 and continue past Mulino. Just south of the Molalla River, turn right at the Arrowhead Golf Course. To get to the Vaughan House, continue a short distance south on Highway 213 and at the Liberal Country Store, turn left onto Macksburg Road and travel 2.3 miles until you see the large white house with white picket fence on the right side of the road. If you are coming through the city of Molalla, take State Highway 211 eastbound - turn left past the lumber mill onto Macksburg Road and travel 0.7 miles until you see the Vaughan House on the left side of the road.



**As an introduction** to Co-Presidents Nancy Root Parker, Diane Root, our newsletter editor, Jacob Root, and finance committee member Mary Laws, we offer a bit of our family genealogy. The following is an exciting find for those of us descended from Reuben and Sarah Owsley Price, and a brief summary of the trip west.

This letter was published in the "Religious Telescope", the United Brethren Church newspaper in 1854. It answers several questions, in particular whether the Price twins were born on the Oregon Trail. Reuben clearly states they were 10 months old when they started! Reuben Price was one of the lay ministers in the United Brethren wagon train. Thank you to Margaret Pritchard for her clue to look into research at Huntington University (Huntington, Indiana), United Brethren Historical Center, archives of the Church of the United Brethren in Christ. #### LETTER FROM OREGON

Dear Bro L .:- It is with much pleasure and delight that I take my pen to hand to inform you and the brethren of our safe arrival in this far off yet beautiful country. We have been in the Willamette valley some five or six weeks, and after considerable deliberation have settled in this beautiful little town called Albany. It is situated on the Willamette river, twenty-five miles above Salem.- We started from Fort Desmoines, Polk county, Iowa, on the 20th day of April. My family consisted of myself, wife, and eleven children. Our youngest (twins) were about ten months old when we started. We had some considerable sickness on the route, but by the blessing of God, and the prayers of the church we are all here in good health. My wife's health was so poor when we started from Iowa that I had to carry her to and from the wagon. She enjoys better health now than ever before.

In crossing the plains we lost in wagons, stock and expenses about two thousand dollars, yet what we have left is worth more than it was in the states. We have commenced the mercantile business here and are doing well. The grass is about six inches high, and as green as a meadow. It looks more like the month of May than November. We would rather be here with all our losses and crosses, and with all the perplexities in so long and perilous

a journey, than to be back in the states. I would recommend it to all persons wishing to cross the plains to start with good mares and mules, for this reason: one of my friends here started across the plains this season with horses. He suffered no loss, and made the trip in about three months, while we, with all our losses was nearly six months in getting to this place. I would recommend also, to cross the Missouri river if possible, by the 20th day of April; as the early part of the emigration did not suffer such loss of cattle, as we that were much later. As a general thing it was very healthy on the plains this season. Flour is worth \$8 per 100 lb, wheat \$2 per bushel, potatoes and oats \$1 per bshl, corn \$2 per bshl, beef is from \$10 to \$15 per 100 lb, pork is \$15 per hundred, oxen \$150 per yoke, cows \$100 a piece, good mares \$200, good wagons \$150 a piece. Goods as a general thing are about 50 percent higher here than in the states.

The prospects for a United Brethren society in and around this place is somewhat flattering. I hope you will give this letter a place in our excellent paper for the benefit of our old friends and acquaintances, and the church generally. Please direct my paper to this place.

> REUBEN PRICE Albany, Linn Co, Oregon territory, November 7th, 1853"

Note: Reuben Price moved from Albany to take up a Donation Land Claim in Umpqua (Douglas) County, Oregon, north of Oakland, an area where the United Brethren Church was being established.

Grades 5-8 \$200 cash
Grades 5-8 \$200 cash
Essay of at least 200 words telling something you have learned about the migration to Oregon that you would like to share with us.
Grades 9-12 \$500 cash to further your education Essay of at least 500 words telling what being an Oregon pioneer descendant means to you.

# Miss Pioneer Oregon 2013

Applications are now being accepted for Miss Pioneer Oregon 2013. Here is an opportunity for young women with Oregon pioneer ancestry to be selected as an official representative of Sons and Daughters of Oregon Pioneers. The successful candidate is rewarded with the honor of being selected and monetary benefits.

#### **Requirements:**

- 1. Open to any single woman, age 16 21, who is eligible for membership in SDOP as a direct descendant of an Oregon pioneer. The pioneer ancestor must have arrived and settled in the Oregon Territory before statehood, Feb. 14, 1859.
- 2. If selected, she is required to attend the SDOP Annual Statehood Banquet in February and give a five minute speech on Oregon history or her pioneer heritage. She also is required to attend the annual SDOP picnic in July.
- 3. Unless unavoidable conflicts exist, she is expected to attend the Founders Day celebration at Champoeg State Park in May and the SDOP annual meeting in June. She may also volunteer to take part in festivals, celebrations, fairs, and parades sponsored by other organizations.
- 4. She is required to appear at all official functions in pioneer costume with the special "Miss Pioneer Oregon" sash furnished by SDOP.
- 5. She is required to have a studio portrait made for programs and publicity purposes. The portrait (2 -8x10s and 1 5x7 for the Newsletter) will become property of SDOP, and the cost of the portrait will be paid by SDOP (up to \$100). One complimentary copy of the portrait will be presented to her.

## Selection Criteria:

Applicants will be judged by the selection committee based on (1) poise; (2) appreciation of Oregon pioneer heritage; and

(3) willingness to represent SDOP at official functions during the calendar year of 2013. Decision of the judges is final. **Benefits:** 

Miss Pioneer Oregon will receive a cash award of \$500 paid in two payments, a Life Membership in SDOP with the hopes of participating in the organization in the future as a board member or officer, and the privilege of officially representing SDOP for one year.
