Some interesting Champoeg State Park history

Our wonderful SDOP Historian, Janet Wilson, has been using some of her isolation time at home to review some of SDOP's historical files. To her amazement she found an article dated January 27, 1937, during Governor Charles Martin's administration, about the Champoeg Park Commissioners and Janet's Great, Great Aunt, Mrs. Mary Drain Albro.

It seems Mrs. Albro (a member of SDOP) and others were dismissed as Park caretakers by the Commissioners of the Park because they protested excessive removal of native trees and shrubs from the Park. (Most likely this statement refers to removal of native trees and replacing them with the grove of non-native Sequoia trees, planted along the road leading to the Monument/Pavilion.)

Mrs. Albro and others then took their protest to the Governor, Charles Martin (January 14, 1935 – January 9, 1939), asking that all the commissioners of the park resign, which was adopted. Governor Martin agreed with Mrs. Albro and her special committee who insisted that the park must be preserved as a Shrine to Oregon Pioneers. The Governor agreed, and in his letter to the Sons and Daughters of Oregon Pioneers stated: "I feel that Champoeg Memorial park belongs to the Sons and Daughters of Oregon Pioneers and I am prepared to go along with them in anything they want to do with the Park."

New recommendations were adopted, namely, that "the Sons and Daughters of Oregon Pioneers make Champoeg Park their principal mission and advise the governor, other state authority and federal administration of their desire to serve and cooperate to fullest possible extent." SDOP made several recommendations which included building a modern road to the entrance, that an arboretum be established on the now unwooded section of the

108 acre tract and a comfortable building be erected on the property, the Pavilion, and not a big auditorium originally suggested by the park Commission. Most importantly, SDOP proposed that the park be used as a means of teaching Oregon History. These recommendations along with others were filed with the governor, members of the state board of control, the Champoeg Park Commission and the State Highway Commission, and the historical distinction of Champoeg Park was filed with the Federal Government.

We can thank Mrs. Mary Drain Albro and other SDOP members that Champoeg Park is the park it is today, in its native simplicity, adorned with the flowers (Camas Lilies in the fields), shrubs, and trees of Oregon. It is a setting that draws attention to the Willamette River, the early artery of transportation and especially as a shrine to the memory of Oregon Pioneers and the vote taken in 1843 that would keep the Oregon Territory under the American Flag.

HI SDOP Rose Parade fans,



Carolyn was a 4th Great Granddaughter of one of the first folk hero frontiersmen, Daniel Boone. She graduated from Multnomah Elementary & Jackson High School. Carolyn retired after 31 years as a Food & Nutrition Manager at Oregon Health Sciences University. She was a Charter & Life Member of The Boone Society, Inc., a Kentucky Colonel, Life Member & past Co-President of Sons & Daughters of Oregon Pioneers and a member of Wilsonville-Boones Ferry Historical Society. She was a past member of Multnomah Historical Association & Lincoln County Historical Society. Carolyn passed away following over 10 years bravely battling serious illnesses. Carolyn spent 69 selfless years putting others before herself. Her determination & clarity of mind were an inspiration to all. She was preceded in death 11 weeks prior by "the love of her life" for nearly 40 years, Rodney Bickham. She is survived by her daughter & loving caregiver Richelle Fitzgerald, grandson Payton Fitzgerald, granddaughter & husband Marijane & Zach Stafford, Rodney's 4 daughters & 10 grandchildren and her sister Janet Boone McGarrigle. A private burial at sea is planned for Carolyn & Rodney.
