Newsletter Note:

Each year, while budgeting, the SDOP finance committee looks at all expenses with an eye on saving where possible while still providing members the most benefit for their membership dollars. The single largest expense each year is the cost of printing and mailing our much coveted SDOP newsletter. Currently the cost of printing and mailing a newsletter by US Postal Service is \$8.00 per year. With annual dues at \$20 for Adults, \$15 for Seniors, and \$8 for Juniors, the newsletter cost takes a large share out of our organization's income.

So, what to do? Raise dues? Hopefully not. Charge extra for newsletters in our dues for those that want them? We work to keep the dues as stable as possible, so for now those options are not under consideration. If you do have computer access, though, then the best option is to take your newsletter by email. Why should you take the newsletter by email? First, the quality of the newsletter is much higher with color pictures and other graphics in color as well. It can be viewed on

the screen or you can print it on your printer. Then your own printed version can come out in color! To be sure for those members who need a printed version for whatever reason it will still be available, and you need to take no action to have it continue.

What else do you get? We do occasionally send additional articles and announcements out to members who receive their newsletters by email. These materials are often too large and expensive to send by regular mail, but they do add to your SDOP membership experience.



To Sons & Daughters of Oregon Pioneers Members,

Jesse Boone (great grandson of Daniel) and his family were instrumental to the establishment of the Boones Ferry and the building of Boones Ferry Road, both critical transportation links in the history of the Northern Willamette Valley. Yet he and most of his family lie in unmarked graves in the local Butteville Cemetery. The Wilsonville-Boones Ferry Historical Society and the Butteville Pioneer Cemetery Association are working together to provide them with appropriate cemetery monuments.

Zoom Meeting

Call to Order: Meeting called to order at 10:17 am by President Joy Eaton.

Officers' Reports:

Secretary: Dawn read the minutes from the June meeting. Dave made a motion to accept the report. Eleanor 2nd the motion. Motion passed.

President: Joy welcomed everyone and spoke about our current state with zoom meetings and how our ancestors would react to our situation. Public Relations: Joy invited Gerry Frank to speak at the banquet or the picnic in 2021.

Membership Registrar Report: Priscilla gave an updated membership report: added 1 adult membership. 1 new senior member. 1 changed from yearly to life. Priscilla found a 4-drawer file cabinet.
