## 4<sup>th</sup> grade Essay Contest

#### **RULES:**

- 1. Applicant must be a 4<sup>th</sup> grade student in a public, private, or homeschool curriculum in the state of Oregon.
- 2. All entries must be postmarked by **May 15 of the contest year** or delivered to the Chairperson by the same date.
- 3. Judge's ruling will be final.
- 4. Winners will be awarded at the annual SDOP picnic, the 2<sup>nd</sup> Saturday in July, at Champoeg State Park, but need not be present to win.
- 5. Must be entirely the work of the applicant.
- 6. It is preferable that the essay be typed; however, an essay that is neatly handwritten in ink will be accepted. Typed essays should be double spaced, minimum 12 point font (Arial or Times New Roman preferred), 1-inch margin, and maximum length of 2 pages. Handwritten essays should be ink on lined notebook paper with a maximum length of 3 pages.
- 7. Essays must be submitted with the **cover sheet** that includes the student's contact information.
- 8. A **picture** of applicant **must** accompany entry. Also, the **signed Photo and Essay Release Form** must be attached.
- 9. Entries can be sent in by individuals or in class sets by a classroom teacher, but each entry must have the required materials attached.



#### **TOPIC, CRITERIA, AND AWARDS:**

Essay: "Discuss the pioneer spirit, a determination of accomplishing goals under very difficult circumstances, and how the result of that spirit has affected our lives today."

#### Judging Criteria:

- How well the topic is addressed
- Command of conventions of standard English grammar and usage
- Organization of details
- Use of primary and secondary sources
- Sources must be cited


Awards: 1st place winner will receive \$150.00
