Completed application is due by December 15. SDOP Annual College Scholarships This scholarship, worth up to \$1,000, is offered to up to two SDOP members to help achieve their goal of earning a first bachelor's degree. The application packet should include written responses to five questions, a sealed copy of official transcripts from the most recent high school, college, or university, and a completed application. Due by December

Sons and Daughters of Oregon Pioneers Board Meeting Minutes

November 18, 2023, Clackamas Town Center

Call to Order at 10:10 a.m.

Attendance Record: Jeanne Preston, Joyce del Rosario, Chris Meinicke, Shauna Noon, Joy'e Willman, Mel Fuller, Sherry Fuller, Reggie Burke, Janet Wilson, Dave Thompson, Debbie Pedersen. Quorum established. Guests: Terry Thompson, Leif Lidin-Lamon.

Officer's Reports:

Secretary: Joyce del Rosario reported minutes from September 23, 2023 meeting were shared with board by email and published to members via newsletter in advance of the meeting. No additional comments or changes were suggested from the floor. Janet Wilson moved and Reggie Burke seconded to accept the minutes as to form and content; no objections stated and a vote was not called.

President: Jeanne Preston reported that she has been working with Chris Meinecke on the Annual Banquet. Jeanne and Shauna Noon worked on the annual budget.

President-Elect: Chris Meinicke - President-Elect reported on banquet.

New Business and Annual Banquet – Chris Meinicke contacted Monarch Hotel to get a lower cost room to accommodate 60 people at \$1600 + 22% gratuity. Chris suggested a pasta buffet at \$34 or a plated meal (steak, chicken, or salmon) at \$38 per meal. Shauna Noon will look at the Milwaukie Elks. Joyce del Rosario will investigate additional venues in the area.

Treasurer: Shauna Noon delivered a Treasurer's Report and led the discussion on the proposed budget of three items.

- 1. The board discussed zeroing out the parade costs at \$3000; discussion was not accompanied by a motion.
- 2. The board discussed the annual birthday banquet being organized by Chris Meinicke; no amount was approved nor was any motion offered.
- 3. Debbie moved to print the bi-monthly member newsletter in black ink on white, cream or colored copy paper, like was done in the past, so current subscribers would ultimately discontinue requesting print editions. The motion was not seconded, but a vote was called and motion carried.

Committee Reports:

Nominations: Chris Meinicke conducting the nomination committee meeting for FY 24-25 at the November

meeting. Resulting Slate: President: Chris Meinicke, President-elect: Joy'e Willman, Secretary: Joyce del Rosario, Treasurer: Shauna Noon. Sherry Fuller was asked to serve another 3 years on the board.

Membership/Registrar: Debbie Pedersen reported six (6) new members joined and one converted to Life membership since the last meeting.

Correspondence Secretary: Debbie Pedersen has modified the language for future donation receipts to state that no goods or services were exchanged for the donation made on the applicable transaction date.

Website/IT: Mel Fuller answered questions about registration process and IT system touchpoints. Shauna Noon volunteered to take over the Caspio database management.

Newsletter Editor: Joyce del Rosario asked for column contributors to have content in editable formats at their soonest opportunities to make a month end publication deadline. Joyce explained that there needs to be a reasonable time for the board to review minutes after each meeting before the minutes are printed for additional review.

Social Media: Janet Wilson reported the Facebook page has over 1,200 subscribers.

Trading Post: Reggie Burke reported \$16 in sales for this fiscal quarter, mostly from mugs.

Old Business:

New brochures. Dave Thompson shared a full color version of the printed brochure for review and approval.

New Business:

Results from contacting delinquent dues. Shauna Noon asked if board members were checking the registration status before making calls. Debbie Pedersen asked where invoices are generated. Joyce del Rosario asked who to send invoice questions to; all invoice questions will go to the Treasurer. Reggie Burke asked to resign from making calls.

Volunteers/Internships – Joyce del Rosario was provided a copy of the internship application from Sandy Historical Society to share with the board for their input/review if SDOP wants to pursue additional volunteers, i.e data science interns.

Sons and Daughters of Oregon Pioneers + Miss Pioneer Oregon +

Applications are now being accepted for Miss Pioneer Oregon. Here is an opportunity for young women with Oregon pioneer ancestry to be selected as an official representative of Sons and Daughters of Oregon Pioneers. The successful candidate is rewarded with the honor of being selected and monetary benefits.

Requirements:

- 1. Open to any single woman, age 16-21, who is eligible for membership in SDOP as a direct descendant of an Oregon pioneer. The pioneer ancestor must have arrived and settled in the Oregon Territory before statehood, Feb 14, 1859.
- 2. If selected, she is required to attend the SDOP Annual Statehood Banquet in February and give a five-minute speech on Oregon history or her pioneer heritage. She is also required to attend the SDOP Picnic in July.
- Unless unavoidable conflicts exist, she is expected to attend the Founders' Day celebration at Champoeg State Park
 in May. She may also volunteer to take part in festivals, celebrations, fairs, and parades sponsored by other
 organizations.
- 4. She is required to appear at all official functions in pioneer costume with the special "Miss Pioneer Oregon sash furnished by SDOP.
- 5. She is required to have a studio portrait made for programs and publicity purposes. Two 8x10s will be paid for by SDOP (up to \$100) with one copy being given to Miss Pioneer Oregon. The newsletter/banquet portrait needs to be sent to Dave Thompson (dave_tek@yahoo.com) for inclusion in the program.

Selection Criteria:

Applicants will be judged by the selection committee based on 1] poise, 2] appreciation of Oregon pioneer heritage, and 3] willingness to represent SDOP at official functions during the year to the next banquet.

Benefits:

Miss Pioneer Oregon will receive a cash reward of \$1,000, paid in two payments, a Life Membership in SDOP with the hopes of participating in the organization in the future as a board member or officer, and the privilege of officially representing SDOP for one year.
