

## President's Letter

From Chris Meinicke



Greetings to all SDOP members, Friends of SDOP and their families,

Hope everyone enjoyed their summer and are looking forward to cooler weather now that Fall is almost upon us. If anyone visited a Pioneer Historical site and/or museum over the summer or in the past year please, send me a brief write-up about your experience with a photo or two. I'd love to include your experience in our next newsletter.

My message for this newsletter is about the history of SDOP since we have many new members and new Board members. Most of my information has been provided to me by Merle Miller, President of SDOP from 1999-2000, and Registrar of SDOP for many years.

In 1873, there was a growing desire on the part of many of the early immigrants who settled the Willamette Valley and

other parts of the Oregon Territory to organize an association to collect stories related to the Pioneers and their early history/experiences of the territory and to gather material for the archives. This became more critical as some of the immigrants began dying off. There were several preliminary meetings and then, in October 1873, the Oregon Pioneer Association became official with the adoption of a constitution and electing an executive Board. The first President, Francois X. Matthieu, was a French-Canadian Pioneer. Matthieu was the founder of Butteville, Oregon. The first annual meeting of the Oregon Pioneer Association was held at Butteville on November 11, 1873.

**Side Note:** Today Butteville, Oregon is home of the oldest continuing operating store in Oregon. It is currently owned by Champoeg State Park. The Boat landing at Butteville has been restored by Friends of Butteville, with most of the work completed in 2018/2019.

The Second annual meeting of the Oregon Pioneer Association was held in Aurora on June 16, 1874. It was resolved by the Association that June 16<sup>th</sup> would be the anniversary day for the meeting/reunion of the Pioneers. We continue to honor that date by having our Annual Meeting as close to June 16<sup>th</sup> as possible. At the annual meeting the newly elected officers are officially installed. The actual picture of this 1874 meeting is at the Aurora Colony Museum.



This is a picture I took of the very large photograph that used to hang at the Old Aurora Colony Museum. Some members have been able to identify their pioneer ancestor in this Picture. The picture is now being stored in the newly built Archive Building. If you'd like to see the picture I suggest you contact the museum ahead of time and let the museum know when you are planning to visit.



The Oregon Pioneer Association became the nucleus of the Oregon Historical Society. The Oregon Historical Society has in their archives many of the original documents from the first meetings of the Pioneer Association.

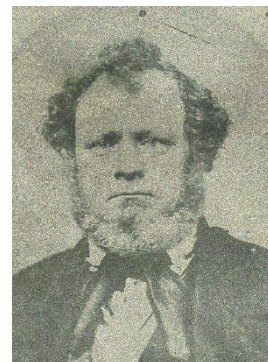
Along the way, membership was extended to anyone who had ancestors in the Oregon Territory prior to 1859, when Oregon became a state.

This included pioneers who came by cover wagons plus those who might have arrived by ship, mountain men, missionaries, adventurers and Native Americans. Some of our current members had family who were members of the Oregon Pioneer Association and/or members of Sons and Daughters of Oregon Pioneers.

The Oregon Pioneer Association became the Sons and Daughters of Oregon Pioneers in 1897 and incorporated on June 13, 1901. In two years, we'll be celebrating the 125<sup>th</sup> year as one of the oldest non-profit Organizations in Oregon. Something to really celebrate! But to keep this organization a viable and an active organization we need more people to step up to become active by getting involved attending meetings, events and offering to volunteer on some of our committees. All members are welcome at our board meetings and especially to the meetings when we meet at historical sites which always include tours. Our next board meeting is November 16, 2024, in a conference room at Clackamas, Oregon.

After their wedding, they climbed into their Conestoga wagon and headed west on the Oregon Trail.

Marie Cathey married Barrett Randall in 1919, who moved to Oregon after graduating from St. Paul Law School. They had two daughters, including Martha Randall Mason, Mason's mother.

Richard Mason graduated from Beaverton High School and attended several colleges including Lewis and Clark, Portland Community College, Cuesta College and Cal Poly, SLO. He also served two years in the US Army. After college. He worked as a radio news reporter and radio station owner for more than 40 years in California. He also worked as a Tour Guide at Hearst Castle State Historical Monument in California. He currently lives in McMinnville, Oregon.

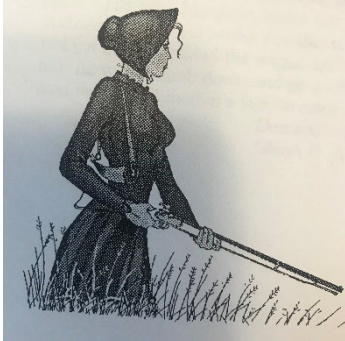

## Reflections of Oregon Pioneers

**Issac Allen  
1846**

Who won?... In May 1846, Issac Allen and his family started the trek on the Oregon Trail from Missouri. His son, William, kept notes along the way. He reports that only one time were they stopped by Indians, about 400 Sioux. The emigrants made a display of flintlock rifles while the Indians had only bows and arrows. Issac had his eye on the chief and planned to pick him off first in case of a fight, but after a meeting, the Indians allowed passage

When it was over, William wrote that his father found he had lost the flint out of the gun, rendering it useless. Needless to say, the laugh was on him, and the old chief never knew of his narrow escape.

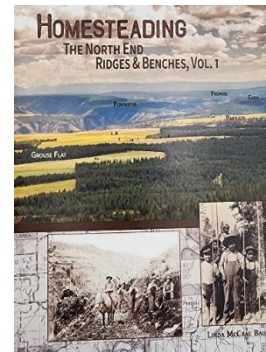

On a side note, Issac Allen was actually wagon master, along with his friend Elam Brown. The company consisted of about 30 wagons, 100 men, plus their women and children. Isaac Allen died on August

27, 1846 on the Humbolt, what is now the state of Nevada. His wife Margaret went on to marry Elam Brown. Elam Brown's son Thomas help to survey and plot the new town of Portland, Oregon. *HOMESTEADING – The North End Ridges & Benches, Vol. 1* by Linda McCrae Bauck



A rare, difficult to find book, but steeped in the history of NW Wallowa country and the southern parts of Garfield and Asotin counties in Washington.

Beginning in the early 1880's, these stories give readers a peek into the hardships and triumphs as pioneers settled into this remote, roadless area. Chapters cover ferries, bridges, roads, post offices, schools, early medicine, farming, social events, and more.

## Sons and Daughters of Oregon Pioneers

### ◆ Miss Pioneer Oregon ◆

Applications are now being accepted for Miss Pioneer Oregon. Here is an opportunity for young women with Oregon pioneer ancestry to be selected as an official representative of Sons and Daughters of Oregon Pioneers. The successful candidate is rewarded with the honor of being selected and monetary benefits.

#### Requirements:

1. Open to any single woman, age 16-21, who is eligible for membership in SDOP as a direct descendant of an Oregon pioneer. The pioneer ancestor must have arrived and settled in the Oregon Territory before statehood, Feb 14, 1859.
2. If selected, she is required to attend the SDOP Annual Statehood Banquet in February and give a five-minute speech on Oregon history or her pioneer heritage. She is also required to attend the SDOP Picnic in July.
3. Unless unavoidable conflicts exist, she is expected to attend the Founders' Day celebration at Cham-poeg State Park in May. She may also volunteer to take part in festivals, celebrations, fairs, and parades sponsored by other organizations.
4. She is required to appear at all official functions in pioneer costume with the special "Miss Pioneer Oregon" sash furnished by SDOP.
5. She is required to have a studio portrait made for programs and publicity purposes. Two 8x10s will be paid for by SDOP (up to \$100) with one copy being given to Miss Pioneer Oregon. The newsletter/banquet portrait needs to be sent to Dave Thompson (dave\_tek@yahoo.com) for inclusion in the program.

#### Selection Criteria:

Applicants will be judged by the selection committee based on 1} poise, 2} appreciation of Oregon pioneer heritage, and 3} willingness to represent SDOP at official functions during the year to the next banquet.

#### Benefits:

Miss Pioneer Oregon will receive a cash reward of \$1,000, paid in two payments, a Life Membership in SDOP with the hopes of participating in the organization in the future as a board member or officer, and the privilege of officially representing SDOP for one year.
