Sons and Daughters of Oregon Pioneers' 4th Grade Essay Contest

Rules

1. Applicant must be a 4th grade student in a public, private, or homeschool curriculum in the state of Oregon.

2. All entries must be postmarked by May 15 of the contest year or delivered to the Chairperson by the same date.

3. Judge's ruling will be final.

4. Winners will be awarded at the annual SDOP picnic, on the 2nd Saturday in July, at Champoeg State Park, but need not be present to win.

5. Must be entirely the work of the applicant.

6. It is preferable that the essay be typed; however, an essay that is neatly handwritten in ink will be accepted. Typed essays should be double spaced, minimum 12point font (Arial or Times New Roman preferred), 1-inch margin, and maximum length of 2 pages. Handwritten essays should be ink on lined notebook paper with a maximum length of 3 pages. 7. Essays must be submitted with the cover sheet that includes the students' contact information.

8. A picture of applicant must accompany entry. Also, the signed Photo and Essay Release Form must be attached.

9. Entries can be sent in by individuals or in class sets by a classroom teacher, but each entry must have the required materials attached.

Topic, Criteria, Awards

Essay: "Discuss the pioneer spirit, a determination of accomplishing goals under very difficult circumstances, and how the result of that spirit has affected our lives today." Judging Criteria: • How well the topic is addressed • Command of conventions of standard English grammar and usage • Organization of details • Use of primary and secondary sources • Sources must be cited Awards: 1st place winner will receive \$150.00 2nd place winner will receive \$75.00

Genealogical Forum of Oregon



Three members of the Daughters of the American Revolution founded the Genealogical Forum of Oregon in 1946 for the purpose of promoting genealogical research through education and providing tools, assistance, and offering expertise to its members. The name was chosen because it reflected the spirit of a roundtable discussion of family history. For the past 20 years, the GFO held meetings at the Meier and Frank building, the Portland Public Library, and other public meeting places.

For many years it held its growing library collection at a member's home. By 1955, the GFO was offering genealogical classes and working with others, such as the Oregon State Archives, to identify and catalog genealogical resources in Oregon. In 1968, the GFO moved into its first devoted library space, a room in the Governor building downtown on Southwest Second Avenue.

Since then, the GFO has moved three more times, jumping the river to the Central Eastside in 1999. In 1991, the GFO successfully hosted the *National Genealogical Conference in the States*, the first national conference of its kind held in the Pacific Northwest. Oregon Governor Barbara Roberts proclaimed Family History Week in honor of the GFO and the conference. The GFO hosted the NGS again in 2001, and at the time was the only organization to host the Conference twice.

In 2011, the GFO moved to its present location in the historic Ford Building at Southeast Eleventh Avenue and Division Street. With 5,000 square feet of space, the library offers computers to access a suite of powerful subscription databases; a film scanner for reading, saving, and printing microfilm and microfiche records; and more than 60,000 holdings.



New Business



Alvin M. Josephy, Jr. was researching a story on Idaho for Time Magazine when he met the Nez Perce. He flew from Boise to Lewiston, where the mayor toured him, including a stop at the Nez Perce Reservations office. A young Indian, seeing "Time," asked Josephy what he knew of the Tribe. Nothing. The mayor chided him, "You don't know about the Tribe that held off four American armies over five months and more than 1200 miles before capture just short of Canada?"

Intrigued, Josephy, who in 1951 was a WW II Marine combat journalist who had walked ashore in Guam with a microphone as comrades were shot, read the white accounts and searched for Indian accounts. He found them in Lucullus McWhorter's Yellow Wolf, His Own Story.

Armed with that account and interviewing and sweating with the few remaining veterans of the 1877 Nez Perce War, Josephy dug in and over twelve years wrote The Nez Perce Indians and the Opening of the Northwest. From there he went on to write more of Indians, and to advocate for them, serving finally as the founding board chair of the Museum of the American Indian. And, while working on that book and visiting Nez Perce country while still working full-time at Time, he found and bought 80 acres near Joseph, Oregon. I came to the country in 1971, and opened a bookstore in Enterprise in 1976. Alvin Josephy became my mentor and friend. Together, with help from recent Oregon Poet Laureate Kim Stafford, we founded Fishtrap, a non-profit promoting writers and writing in the West. As Alvin aged, I toured and chauffeured him with his memoir, A Walk Towards Oregon, and helped coordinate with Native authors for the last book he edited, Lewis and Clark Through Indian Eyes.

Like many writers, and especially writers before Google, Alvin had an extensive library of books and journals about his subjects, Tribes and the West. On our book travels, we talked about finding a home for them here in the Wallowa's. And, as it turned out, we did. Alas, it was after Alvin had passed, but his children and grandchildren can and do visit the Alvin and Betty Josephy Library of Western History and Culture. Which is just part of the Josephy Center for Arts and Culture. The Center offers classes, produces art exhibits and hosts musical events.

The library the "culture" part of Arts and Culture, has some 2000 books and probably that many historical journals, and a web page with links to ephemera that Alvin collected and that we continue to collect. There are also a few audio and audiovisual items archived. The web page--<u>https://library.josephy.org/--will</u> shows a set of interviews that Alvin did of Lakota elders in 1981-82; hours of video interviews of and about Alvin; and even the recording he made going in at Guam! We have also annotated Alvin's books and now have most of his journal articles digitized so that readers can easily access them.

In the beginning—now over a dozen years ago—we thought that we would be a noncirculating library, and in fact we do have some books valuable enough to remain here. But we have now decided, and have the staff to do this, to circulate most of the collection. The books are cataloged on the SAGE Library System-- <u>https://cata-</u> <u>log.sage.eou.edu/eg/opac/home</u> --and a library card from any SAGE library in Eastern Oregon gives you access to interlibrary loan. For others, we can make arrangements.

The web page also contains my blog posts—there are over 200 of them now relating to local and Indian history and culture. There are also virtual exhibits drawn from several exhibits that we have curated over the years: Dams and Salmon; Nez Perce Treaties; Nez Perce Music, etc. Currently, a physical exhibit designed and built for the Oregon State Capitol, is on display at the Blue Mountain Community College library in Pendleton. It is called "*The Nez Perce in Oregon - Removal and Return.*" It will be shown at the State Capitol in September.


